USES

Bostik UltraGrip is a specially formulated non-toxic high strength acrylic stud adhesive designed to minimize nail and screw "popping" caused by timber shrinkage or frame movement. Bostik UltraGrip reduces the quantities of nails and screws required to fix plasterboard, therefore reducing the fastener head stopping and finishing requirements Bostik UltraGrip can be used for:

- Fixing plasterboard to steel or timber studs and frames (in conjunction with nails and screws)
- Filling irregular gaps between plasterboard and frame
- Bonding timber to concrete or metal
- Bonding chipboard, plywood, masonite and HardieFlex™ sheeting to joints or solid floors/ walls

DIRECTIONS FOR USE

Read and understand the Safety Data Sheet before using this product. SDS can be acquired by visiting www.bostik.com.au or by scanning the relevant QR code on pack.

SURFACE PREPARATION

1. All surfaces must be clean, free from dirt, dust and laitance and loose material
2. All surfaces to be treated must be structurally sound and all previous coatings and adhesions removed prior to application of Bostik UltraGrip
3. All surfaces must be dry and free from moisture.
4. Bostik UltraGrip must be used in conjunction with nails or screws and is not single plasterboard sheet fixing system

APPLICATION

Sausage application:

1. Hold sausage upright and cut the top off the foil below the metal clip
2. Place sausage into 37cm barrel gun then screw on end cap with nozzle
3. With controlled gun trigger pressure, apply Bostik UltraGrip to wall studs and ceiling joists or battens in daubs 15mm to 25mm high

Pail application:

1. Apply Bostik UltraGrip to walls in controlled daubs at 120mm centres and a minimum of 200mm from fixing points from the edge of the board
2. Ensure full contact between the sheets and Bostik UltraGrip until adhesives sets. Ceiling daubs should be 200mm and 400mm from recessed edge.
3. Do not nail or screw through Bostik UltraGrip. Walls should be nailed at 150mm centres, opening at 300mm centres. Ceilings should be double nailed at centre line of ceiling joists 60mm apart.
4. Nail edge sheets at butt joints, around openings and ceiling joist at 150mm centres. Or nail or screw the wall and ceiling sheets in accordance with board manufacturers' instructions.
5. Bostik UltraGrip will dry and gain full strength in 24 hours. No mixing is required, simply use directly from pail.

LIMITATIONS

- Do not use on moist or wet timber
- Do not apply to pre-painted surfaces
- Not suitable as a tile adhesive
- Internal use only
- Do not apply on unseasoned or green timber
- Use in conjunction with screws or nails to fix plasterboard.

CLEANING

Remove uncured (wet) adhesive with water or Bostik Handy Wipes before adhesive cures. Cured adhesive is best removed by mechanical scraping or sanding. Use Bostik Handy Wipe towels to remove adhesive from skin.

STORAGE AND SHELF LIFE

Store in a cool dry place between 5°C and 27°C and keep out of direct sunlight. DO NOT FREEZE. Replace lid tightly when not in use. Shelf life is 12 months from the date of manufacture when stored as directed.

DISPOSAL

Empty sausages and pails may be disposed via local landfill. If spilt, absorb with clay, sand or earth. Collect and seal in properly labeled metal container. Dispose of according to local authority regulations. Do not dispose of down drains or into local waterways.
